Note: local SD's in Spokane have possibly utilized this. Can this be a service funded by Medicaid and provided to clients/families? Note from Convener: HCA contracts directly with providers such as SMS for Medicaid funded transportation. We have sent this issue to the State FYSPRT- need to follow up.</p> <p>Rehab Case Management Funds/CLIP facilities: warm hand offs from CLIP facilities to WISE program services?
