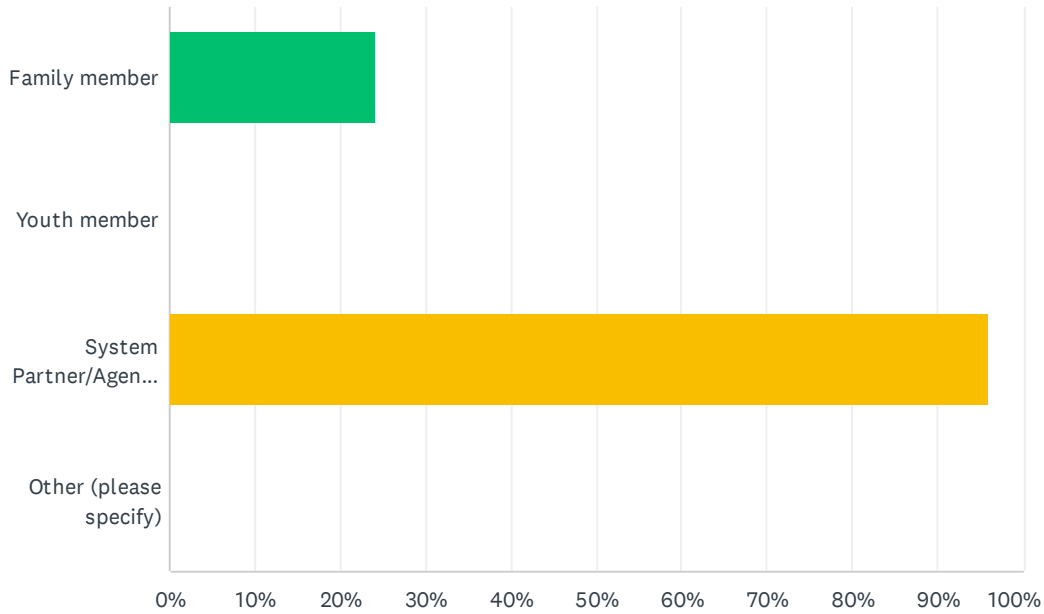

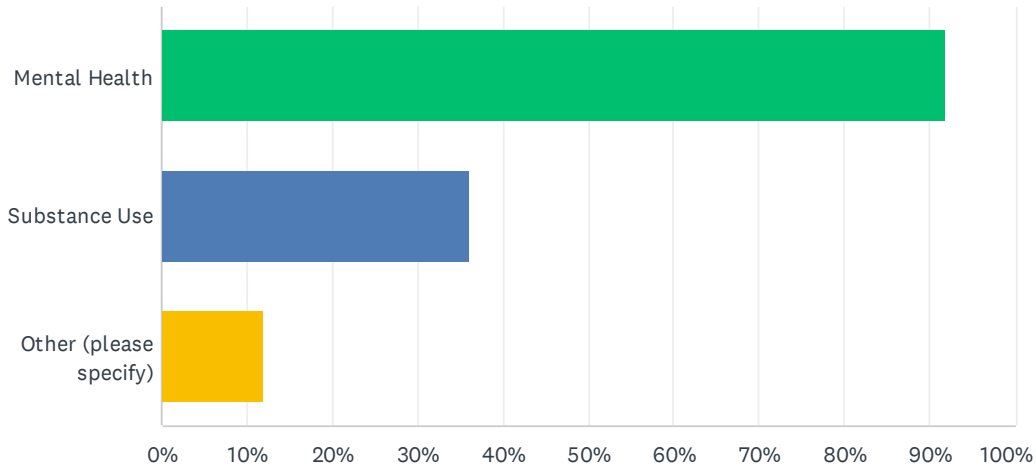

Q5 Do you have primary interests or experience with

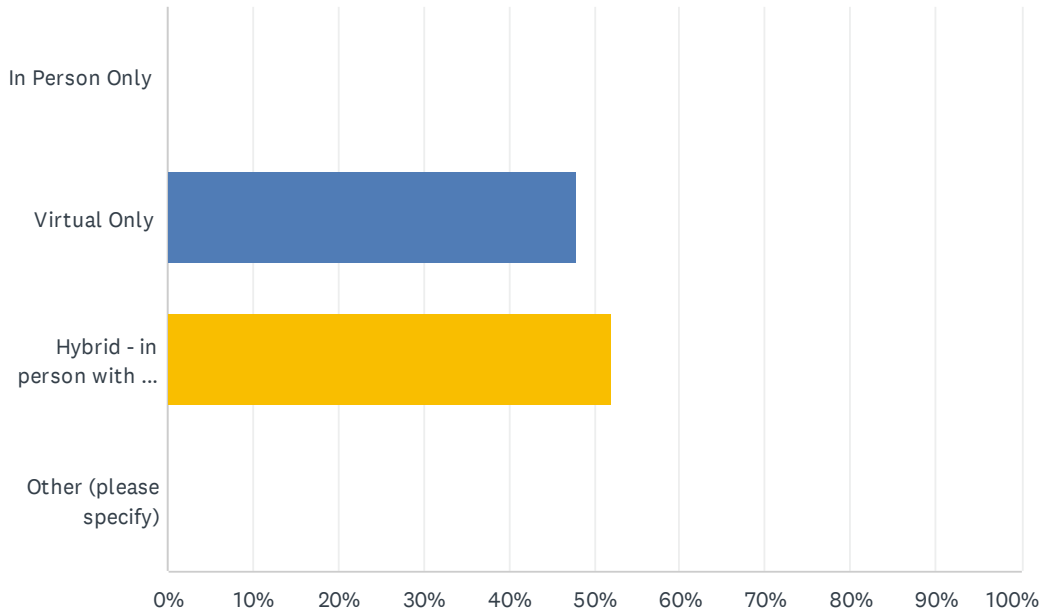
