I get a denial in the mail. Our prescriber is working on it but he was just as surprised.

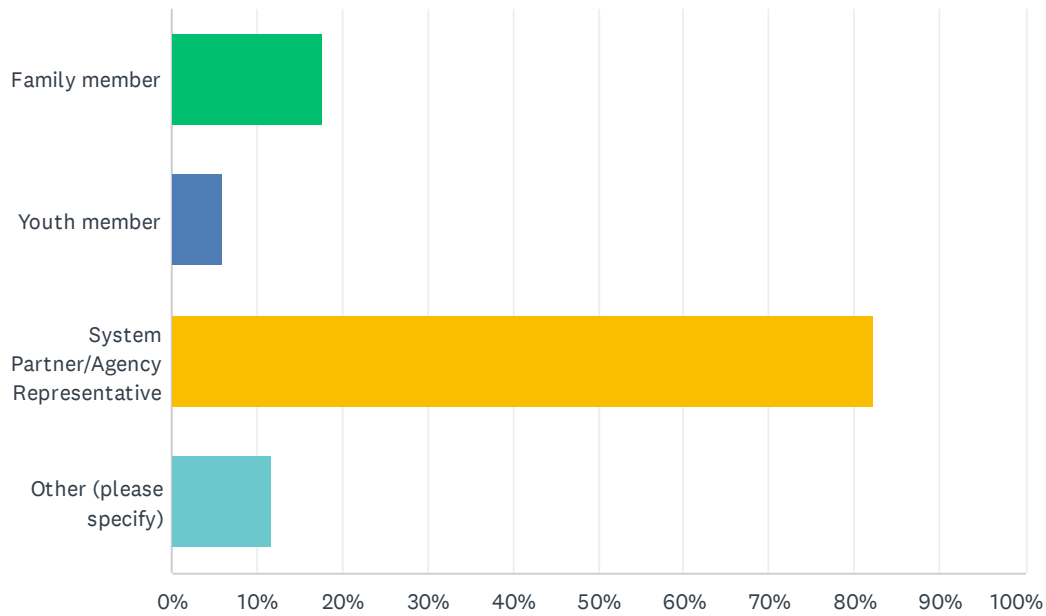
So maybe someone who could go over coverage and processes if it is denied. I

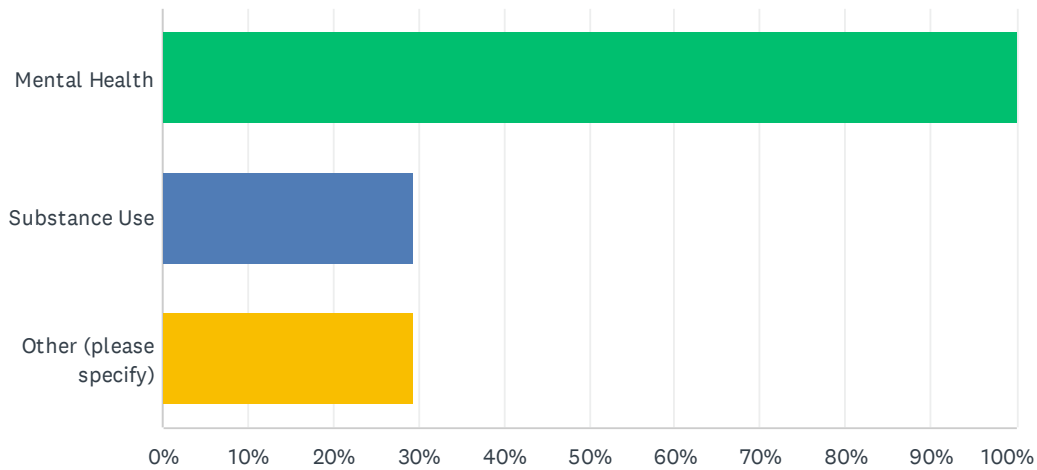

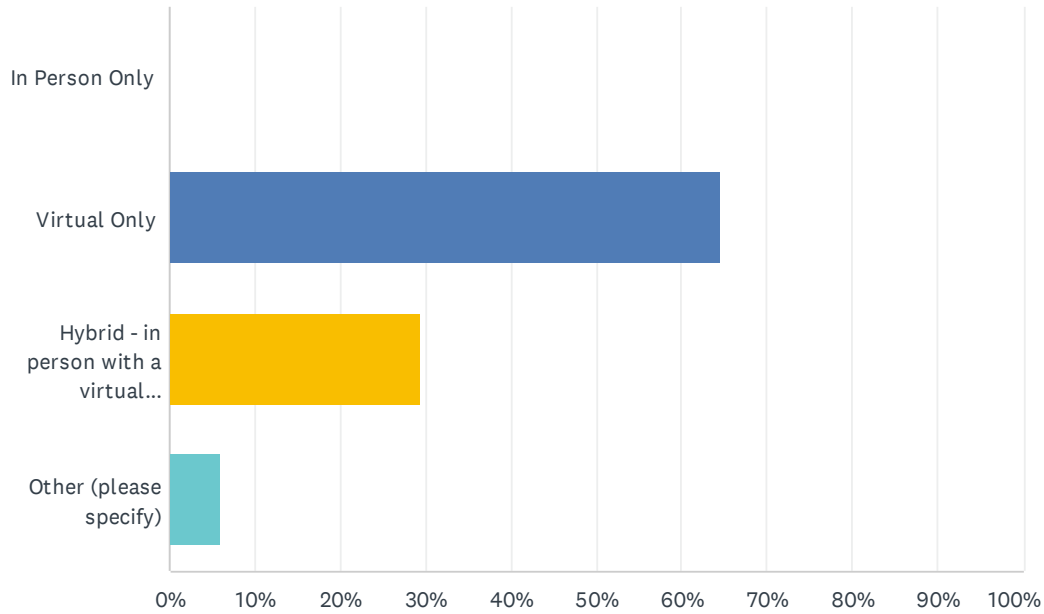
